

GUIDE TO ONLINE LAW RESOURCES LIBRARY DATABASES FOR YOUR LEGAL RESEARCH NEEDS

HOW TO ACCESS CDAsia Classic AND OTHER MULTIDISCIPLINARY DATABASES?

- 1. Go to the **Library website** and click the **Electronic Resources quick link**.
- 2. On the Electronic Resources page, scroll down and select from the list of available electronic databases.
- 3. Click the database title or logo. You will be redirected to your **Google Workspace Account login page**. Enter your login credentials.
- * If already signed in to your Google Workspace Account, you will automatically be redirected to the database homepage after clicking the title or logo.

How to access MyLegal/hiz DATABASE?

- 1. Go to the **Library Website** and click the **Electronic Resources quick link.**
- 2. On the Electronic Resources page, click the **e-Databases link**.
- 3. Scroll down the list of available electronic resources to find **MyLegalWhiz**.
- 4. Get your login credentials by completing the form linked in the database description using your Google Workspace Account (UST email). The Username/Email and Password will be sent automatically to your UST email.
- 5. On the Electronic Resources page, click the database title or logo and enter the received login credentials.

Provides access to the most comprehensive single repository of law materials for your Philippine legal research needs. All materials are gathered only from official sources and include the complete text, footnotes and images.

MyLegalWhiz

Curated and annotated Philippine legal content accessible across all platforms – tablets, smartphones, laptops, and desktops.

Selected Multidisciplinary Databases with Law Collections

BLOOMSBURY COLLECTIONS

Features full access content on at least 48 subjects of law, such as constitutional and administrative law, public international law, human rights, comparative law, legal philosophy, criminal law, legal history, socio-legal studies, etc.

BRILL

Offers subscribed, free, and open access books and reference works on human rights, humanitarian law, and international law.

Cambridge Core

Provides access to books and journals in private and public law subjects. Particular strengths lie in international law, human rights and transitional justice, transnational and comparative law, jurisprudence, and legal history.



Provides access to e-books, e-journals and a variety of proprietary full text databases. The comprehensive databases range from general reference collections to subjects specific to law.

EE Elgaronline

Offers a comprehensive collection of e-books in various fields such as law, economics, business, and social sciences.

JSTOR

Provides access to journal articles, books, images, and primary sources in 75 disciplines, including criminal justice and law.

ScienceDirect

Contains open access, subscribed, and complimentary access to scholarly books and journals in the field of law.

Wiley Online Library

Offers a collection of reference works, journals and books on law and criminology.
